ORDER

The above-entitled matter came on for consideration by the Honorable Senior Judge Ernest C. Torres on the Motion of Lien-Holder Noel & Gyorgy LLP to Release Money from the Registry of the Court, and the Motion of Cherokee, Inc. and Target Corporation to Release Money for the Registry of the Court. After consideration thereof, it is hereby

ORDERED, ADJUDGED AND DECREED

The Clerk, having received the Federal Tax Identification Numbers for both payees, Noel & Gyorgy LLP and Duffy Sweeney & Scott, Ltd., shall forthwith take the following actions:

1. Calculate and account for all interest earned on the amount held in the Registry of the Court in this matter since on or about February 28, 2007;
2. Deduct and retain ten-percent (10%) of the interest accrued as its own fee, in accordance with Local Rule Cv 67(c);
3. Of the remaining interest amount held ("Remaining Interest"), calculate shares thereof in accordance with the respective Bills of Costs entered in the matter, namely:

$8,814.55/10,023.44 \times 100 = 87.9\%$ for Style Accessories' Bill of Costs

$1,208.89/10,023.44 \times 100 = 12.1\%$ for Target Corporation's/Cherokee, Inc.'s Bill of Costs

4. Issue payment in the amount of \$8,814.55 plus 87.9% of the Remaining


